DEMAND LETTER – MISE EN DEMEURE :

Subject : Request for documentation and information

Mr. Haralambos (Harry) Babaroutsis,

As a members of the Board of Directors (hereinafter "B.o.D.") of the Board of Directors of the Hellenic Community of Greater Montreal (hereinafter "H.C.G.M."), we the undersigned, Elias Hondronikolas and George Kanellakis, put you on notice and request that the following documentation and information be provided to us.

As you know, as members of the B.o.D., we have the right and obligation to have a clear knowledge and understanding of the organization's financial standing and operations in order to make decisions for the benefit of the H.C.G.M. In order to do so, we must obtain clarifications in regards to the financial standing and expenditures of the H.C.G.M.

Currently, we are discovering certain information about the operations and evolution of the H.C.G.M. via the local media or external sources. This is a substantial constraint to our role and a serious liability.

Therefore, we request, in writing, that you provide me the following documented information:


- 1) The Minutes of the meetings and list of attendees of the B.o.D. meetings from November 2019 to present.
- 2) The Audit Committee's report for the periods of 2019-2020 and 2020-2021; which are still pending;
- 3) The complete file pertaining to the reconstruction cost of "Panagitsa" church;
- 4) The complete file pertaining to the erection of the aerial bridge for St-George's Cathedral, including but not limited to the tender process and all other work performed to the premises.

- 5) A copy of the deed of transfer of the Foyer Hellénique de Montréal to the H.C.G.M., including all the minutes of meetings relating to it, inclusive of financial statements from July 1st 2019 till June 30th 2021.

Be advised, in the event that the organization refuses to undertake and assume the costs associated with providing us with the above listed copies of the documents, we are willing and capable to undertake and assume those costs. We are also available to assist the employee of the organization, as to expedite the process.


Should you fail to respect the demands contained herein within **10 days** following reception of this DEMAND LETTER, we will take all necessary measures we see fit to ensure our demands are met.
